Pillaton Village Hall 200 Club Terms & Conditions

- 1. The Club shall be known as the Pillaton Village Hall 200 Club.
- 2. The sole purpose of the Pillaton Village Hall 200 Club is to raise funds to maintain and improve the facilities of Pillaton Village Hall together with land owned by Pillaton Village Hall CIO and, after payment of prizes and expenses, all remaining funds shall be devoted to these purposes.
- 3. The Pillaton Village Hall 200 Club is open to all residents of Pillaton and the surrounding area, their family and friends, over the age of 16.
- 4. The Pillaton Village Hall CIO trustees reserve the right to alter the rules of the 200 Club, at any time as may be necessary.
- 5. Chris Ley is the appointed promoter.
- 6. The Pillaton Village Hall 200 Club shall be a small society lottery and shall be run in accordance with the provisions of The Gambling Act 2005. In accordance with para 38 of the Schedule 11, Part 4 of this act, the lottery is registered with Cornwall Council under Registration Number LI15 003139.
- 7. The Pillaton Village Hall 200 Club subscription shall be £24 per annum per number to be paid by 1 November each year. Payment ideally to be made by BACS or by cheque. Subscriptions made subsequently will be agreed with promoter on a pro rata basis (e.g. 1st January £20, 1st June £10).
- 8. Each member shall be allocated a number and advised in advance of the number which will be used in all draws. Members may take out multiple numbers on receipt of multiple payments.
- 9. No refunds can be offered once subscriptions are paid.
- 10. The lottery draw takes place each month. Each draw is conducted in the presence of three or more persons including at least one Village Hall Trustee and one independent member of the public. Before each draw is made the Chair of the Trustees can order a spot check to ensure all entitled numbers are included in the draw.
- 11. Prize money shall be 50% of the money raised; the percentage may be varied from time to time by the Trustees of Pillaton Village Hall CIO.
- 12. The winning numbers will be announced on the Pillaton web site and Pillaton In Cornwall Facebook page. Prizewinners will receive their prize money by BACS payments or cheque.
- 12. The Village Hall CIO bank account, to which all receipts are credited and from which all prizes are paid, is managed by the treasurer. As required by law, a full summary of all payments and receipts is submitted to Cornwall Council. All profits are applied for the purposes of Pillaton Village Hall. A financial statement of the Pillaton Village Hall 200 Club will be published with the Pillaton Village Hall CIO Annual accounts.
- 13. A register will be kept recording the name and address of each member, any associated email, telephone and banking details, the number(s) allocated to them and the subscriptions received from them. This information will be retained solely for informing winners and issuing subscription reminders.
- 14. Unless otherwise advised, a member will be deemed to have left the Club if his or her renewal of subscription remains unpaid for a period of one month after date of annual renewal.
- 15. Members can cancel their entry in the lottery at any time by giving one month's written notice to the promoter or treasurer (if paying by standing order, they should advise their bank). Any decision to wind up the 200 Club will also be by one month's written notice. At that time, any surplus funds or unclaimed prize money shall be included in the final monthly draw. Under no circumstances can any payments be refunded.
